Membership is only open to those who agree to subscribe to the goals and objectives of the Association and to abide by its Constitution and Bylaws.

The Revenue Reconciliation Act of 1993 has eliminated the individual federal income tax deduction for lobbying expenses paid or incurred as part of membership dues on or after December 31, 1993. Dues payments are not deductible as charitable contributions for income tax purposes. Dues payments (or a portion) may be deductible as a miscellaneous itemized deduction. Those members will not be able to deduct as union dues 2 percent of their AEA dues. This is a percentage attributable to lobbying expenses on the state and national level. The exact dollar amount will vary depending on each member's category of membership.

With full knowledge of the above, I hereby authorize to pay for my membership dues as revised annually in the method of payment selected provided that I may revoke this authorization as of **Sept. 1** of any year by giving written notice to that effect on or before that date. Your membership will be automatically renewed each year and the appropriate dues charged beginning in Sept. of each membership year.

### ATTACH VOIDED CHECK

This authorization is to remain in full force until BANK has received notification from me of its termination in such time and in such manner as to afford BANK a reasonable opportunity to act on it. A customer has the right to stop payment of a debit entry by notification to BANK prior to charging account. After account has been charged, a customer has the right to have the amount of the erroneous debit immediately credited to his/her account by BANK up to fifteen (15) days following issuance of statement of account or forty-five (45) days after the charge, whichever occurs first.

**By signing this membership form, you agree to allow AEA to resubmit any rejected EFT payment for insufficient or uncollected funds up to two times within 180 days, or any rejected debit/credit card payment up to four times within sixteen days of any failed transaction.**
